

## AAMAS 2002 – Exhibitor Information

**Location:** The conference this year is located in Palazzo Re Enzo. will take place in Palazzo Re Enzo, which is in the very center of Bologna. Former residence of the city governor, this 13th century building combines the beauty and charm of the past with the comfort of a modern conference center. You can expect over 800 attendees.



The Exhibits will be displayed at the second floor (two elevators are available), very close to the main conference room so your display booth will catch the eye of many participants.

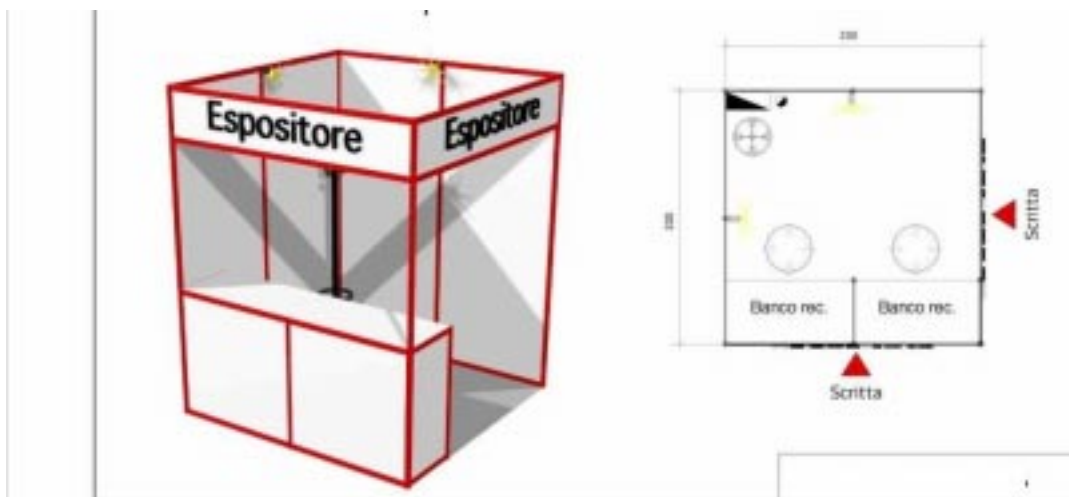


Fig.1: The Small Booth

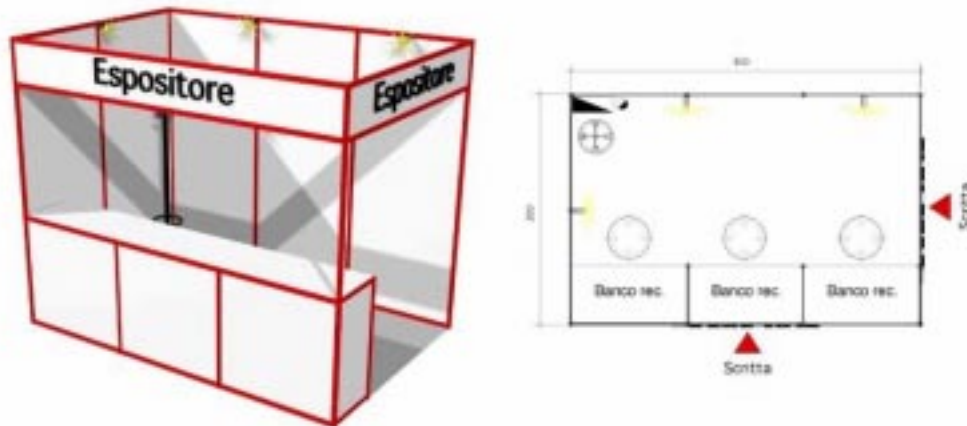


Fig.2: the Big Booth

**Fees:** There is a fee for exhibitors. This fee includes floor space, furniture rental, and electrical hookup for the three days of the conference. (Exhibits and demonstrations will not be displayed during the two days of tutorials and workshops). This fee also includes one full Conference Registration. The total fee is € 600 for the *small* booth (m2x2, see fig. 1), and € 850 for the *big* booth (m3x2, see fig. 2).

**Space:** Each exhibitor will have a booth (see figures 1 and 2) with a basic equipment (see technical descriptions for details). Exhibitor setup will be on the afternoon of July 16, 2002. Exhibits will close the evening of Friday July 19.

**Hours of Exhibits operation:** Exhibits at AAMAS2002 will operate as follows (tentative):

- Setup: 14:00-19:00 July 16.
- Hours: 9:00-19:00 July 17,18,19 (Exhibits to be manned continuously)
- Strike: afternoon of July 19.

**Distribution of Literature:**

1. There will be a table area for placement of flyers and brochures that will not be manned or supervised. This table will be in the registration area for high traffic and good visibility. There is no fee associated with this service.
2. You may supply one page of vendor literature to be packaged with the conference attendee's package (including the programme, proceedings, etc.). There is an additional fee of € 100 for this service. To utilize this service, please contact the Exhibits chair at the address below. Your firm must provide adequate copies (i.e. 1000) of the flyer or brochure (single page standard size or folded) for all attendees. Conference staff will package the materials and each registered attendee will receive a copy.

Please complete and mail/FAX the Exhibitor Application forms as soon as possible. Exhibitor forms are due not later than June 15, 2002. Payment of the fees is due within 15 days (not later than June 30, 2002).
